TOP 10 THINGS TO DO IF YOU ARE ARRESTED IN MASSACHUSETTS

IN THE MEANTIME, CONSIDER THESE 10 WAYS TO GIVE YOURSELF – AND YOUR FAMILY -- PEACE OF MIND DURING THIS DIFFICULT TIME:

- 1) If you have not yet been arrested, but are being investigated by police and fear you might soon be arrested, remember that you do not have to provide police with any information other than your name, social security number and address. Do not volunteer any other information, but at the same time you should not in any way resist arrest. Doing so will only compound the possible charges against you.
- **2)** Remember that a conviction of a crime will haunt you and follow you for the rest of your life. This is the time to put your life in the hands of an experienced criminal defense lawyer who has the expertise, background, and experience in the area where you have been arrested for the alleged crime. Do **not** hire an inexperienced attorney to represent you.
- 3) If you are speaking with several attorneys, make sure to ask them about their independent ranking by a professional rating organization such as AVVO. For example, attorney William D. Kickham has a top ranking of 8.1 out of 10, which is rated "Excellent." Hire criminal defense attorney

- **4) Hire a criminal defense attorney who will offer you a fair and honest evaluation of your case.** Attorney Kickham will provide you with a **FREE** initial case evaluation. Better than that, he will even make a "house call" to you, if you are not available during normal 9-5 working hours.
